

"It's rude to interrupt"

 It's also, generally, against our rules! ^(C) "No member who has the floor may be interrupted except for A point of order A misrepresentation A parliamentary inquiry A point of information, or To call attention that the time has arrived for a special order."

Share (the microphone)!

• No member shall speak

A second time on the same question if another member wishes to speak More than twice on the same subject under the same motion

Longer than three minutes



KEEP CALM AND take turns

Wait to be called on AND take turns

If you want to speak, go to the microphone nearest your seat and wait to be recognized by the Bishop
She will call on members in different sections of the room

 The discussion will alternate between speakers for and against a motion/amendment, so be sure to identify which side of the issue you wish to speak

Consent Calendar

 Administrative and program reports included, as long as no action is required • List of Consent Calendar items Designated with "(CC)" Found on the BWC Website – conference/consent-calendar; and on the BWC Annual Conference App.

Resolutions and petitions are not included on the consent calendar • Ten members or the Conference Chancellor may lift items off the consent calendar by Notifying the Conference Secretary BEFORE the calendar is presented – *noon on* Thursday, June 1, 2017. Form for this is available from a Page and is posted on the Conference website and App.

When does the debate/discussion end?

After three speakers for and three against have been heard; or if
There is no one else who desires to speak; or

Someone "moves the previous question"

Moving the Previous Question

 Means that debate ceases and a vote will be taken on the pending motion

- If secondary motions are pending, the motion to move the previous question should indicate upon which motion the vote to be taken
- Not debatable

 Requires a 2/3 vote of members present and voting

Points of Order

- Go to the nearest mic and indicate: "I rise to a point of order"
- Must refer to the specific rule you think has been violated
- Decision made by the Bishop
- Bishop's decision can be appealed
 - By any member
 - No debate

Presiding Officer and Appellant each have three minutes for a statement in support of their respective positions

Robert's Rules of Order

- Our Rules of the Session govern
 If they don't cover something, then we follow Robert's Rules of Order

Adjourn	"I move to adjourn."	No	Yes	No	No	Majority

Request information	"Point of information" (must be phrased as a question)	Yes	No	No	No

Reconsider previous action (May only be made by a member who voted previously on the prevailing side)	"I move to reconsider the vote on"	No	Yes	**	No	Majority
