# Avoid higher deductibles

HE HEALTH QUOTIENT (HQ) is the second step of HealthFlex's three steps to better wellness. The HQ online risk assessment directs you to wellness resources available at no cost through HealthFlex. If you did Step 1 (Blueprint for Wellness), your health data is automatically and securely imported into your HQ, so it's even easier to complete. You (and your spouse) can complete the HQ even if you missed Blueprint for Wellness. Taking the confidential HQ between August 1 and September 30 will save HealthFlex participants \$250-\$500 on their 2017 individual and family deductibles. The participant and enrolled spouse must complete the Health Quotient to avoid this increase. Adult children are not required.

To take the HQ, visit wespath.org, log into HealthFlex/WebMD and click on the "HealthQuotient" in your Action Plan. You can take the streamlined HQ on your computer, tablet or smartphone. You may also call 1-866-302-5742.

### Online tools can assist in coverage decisions

HERE WILL BE several online and telephonic tools available that will assist you in choosing which plan will work best for your and/or your dependents.

Coverage Advisor is a tool available through WebMD. You can enter details about your family size, general health status, anticipated number of doctor visits and if you have any planned hospitalizations. Coverage Advisor will estimate your out-of-pocket costs under the different options. It can also help you decide how much you may want to contribute toward your person FSA or HSA accounts. This tool will be available the beginning September.

MyChoice is another tool that will



be available during Annual Election (November 2 – 17). It will ask you questions and uses your answers to recommend a medical plan. It can be used online or by phone.

Beginning in late October, you can contact Businessolver by phone for information regarding HealthFlex Exchange. They can assist with basic medical plan information, Health Account information (FSA, HRA, HSA differences and limits), and MyChoice "best options". The toll-free number is 1-844-688-1375. They are available from 7:00 a.m. to 7:00 p.m. Central time.

### Choose your healthplan for 2017 this November

NNUAL ELECTION WILL be held November 2 – November 17. HealthFlex Exchange is a group health plan designed for UMC clergy, lay employees and their families. It brings you more plan options; more flexibility to select the HealthFlex plan that best fits your needs, budget and preferences; and more control over your health care costs. HealthFlex Exchange puts you in charge of your health plan selection, while helping UMC plan sponsors continue to offer health coverage for clergy and lay workers.

## Who gets your benefits if something happens?

O YOU KNOW who you have listed as a beneficiary to receive funds from your retirement account in case you die? Did you have a life event and need to update your beneficiary designation?

Beneficiary designations are required for your retirement account or death benefits and the designation supersedes your Living Will provisions.

Please contact Wespath at 1-800-851-2201 if you need to know who you have listed as your beneficiary; that information is not kept at the BWC Benefits Office.

If you do nothing and the unexpected happens, benefits will be payable ONLY to the estate.

#### **Pre-Retirement Seminar**

The 2016 Pre-Retirement Seminar will take place on Thursday, November 17. Registration can only be completed online. Information on when and how to register will be sent out soon.

This session is intended to explain and highlight the different benefits that are available to clergy at retirement through the denomination, and also for clergy to begin looking at what it takes or how much they will need at retirement so that they can start/increase their personal investment.

### Important changes announced to CPP

OMPREHENSIVE PROTECTION PLAN (CPP) is the benefit that provides, long-term disability, death and other survivor benefits for our clergy. At GC2016, the resolution from Wespath (formerly General Board) to make changes to the CPP eligibility was enacted and this change will take effect January 1, 2017.

#### The current arrangement ending 12/31/2016:

• ALL FULLTIME appointment and ALL full members, provisional members, associate members working less than fulltime (25%, 50%, 75%) MUST be covered in the plan under the special arrangement at a rate of 3.4% of the DAC. This benefit is not available to PTLPs.

#### The new arrangement effective 1/1/2017:

- ALL fulltime and 75% (not including PTLP) appointments to the Local Church and Extension Ministry of which BWC provides benefits for the clergy MUST be covered.
- The rates will now be a straight 3% of total Plan Compensation.
- Wespath has provided all Conferences the path to offer UMLifeOptions

(this is the plan that Conference Lay employees are covered under) to the clergy who are losing coverage.

Conference Board of Pension and Health Benefits (CBPHB) has taken action to try and match the CPP plan option to these clergy who will now be covered in UMLifeOptions and the billing for this new plan is a little complicated because it is based on age and salary, so CBPHB has decided that we will continue to bill 3% of total plan compensation as to avoid little disruption.

Those participants directly affected will be contacted individually.

### GBOPHB adopts name 'Wespath'

HE GENERAL BOARD of Pension and Health Benefits was re-named Wespath Benefits and Investments in July 2016. While they may be changing their name, the people and services you rely on will continue to support your retirement, health and welfare plans, and manage your investment funds.

#### Wespath—symbol and symbolism

The name Wespath was developed in 2010 as the brand for the investments division

as it began to reach out to UMC affiliated institutions, outside normal annual conference connections, to increase assets under management.

The name was created

with two important elements in mind:

Wes—recognizes and honors John Wesley, the founder of Methodism and a strong advocate for social justice;

Path—refers to the goal of providing participants and institutional clients with a path to follow in achieving retirement, health, and investment objectives.

#### **Spousal Surcharge Policy**

Effective immediately, all newly enrolled spouses who have health coverage available through their employer, but who choose to be obtain dependent coverage under the Baltimore-Washington Conference's HealthFlex plan, will incur a surcharge. The surcharge will be the difference in premium to the Conference or \$300.00 per month, whichever is less, in addition to the monthly premium.

This policy will not apply to spouses who are already enrolled in our plan. We strongly encourage you to continue your spouse's health insurance through their employer.
